

Privacy Notice of Neil Mendoza

Thank you for choosing to instruct me in your case (or considering me for such instructions). I will need to collect and hold your personal information in order to represent you. I will take all possible steps to protect your personal information. I am determined not to do anything that would infringe your rights or undermine your trust. This Privacy Notice describes the information I collect about you, how it is used and shared, and your rights regarding it.

Data Controller

I am registered with the Information Commissioner's Office (ICO) as a Data Controller for the personal data that I hold and process as a Barrister. My registered address is Selborne Chambers, 10 Essex Street, London WC2R 3AA and my Registration Number is Z7245388.

Data Collection

The vast majority of the information that I hold about you is provided to me, or gathered, by your solicitor in the course of your case and/or proceedings. Your solicitor and/or I will tell you why we need the information and how we will use it.

The Lawful Basis for me processing your information

The General Data Protection Regulation (GDPR) requires all organisations that process personal data to have a Lawful Basis for doing so. The Lawful Bases identified in the GDPR are:

- Consent of the data subject
- Performance of a contract with the data subject or to take steps to enter into a contract
- Compliance with a legal obligation
- To protect the vital interests of a data subject or another person
- Performance of a task carried out in the public interest or in the exercise of official authority vested in the controller.
- The legitimate interests of ourselves, or a third party, except where such interests are overridden by the interests, rights or freedoms of the data subject.

Examples of legitimate interests include:

- Where the data subject is a client or in the service of the controller;
- Transmission within a group of undertakings for internal administrative purposes;
- Processing necessary to ensure network and information security, including preventing unauthorised access;
- Processing for direct marketing purposes, or to prevent fraud; and

- Reporting possible criminal acts or threats to public security.

The Lawful Basis for my processing of your data, and in respect of my work for you, is

- (i) Consent - by briefing me, or agreeing to me being briefed by your solicitors, you consent to the processing of your personal data by me;
- (ii) performance of a contract - processing your personal data is necessary for me to perform the contract between you and me (if you have instructed me on a Direct Access basis) or necessary for me properly to perform the contract between me and your solicitors (who have instructed me on your behalf); and
- (iii) our Legitimate Interest in me processing your personal data for the purpose of advising you and acting on your behalf pursuant to my instructions

I use your information to:

- Provide legal advice and representation;
- Assist in training pupils and mini-pupils;
- Investigate and address your concerns;
- Communicate with you about news, updates and events;
- Investigate or address legal proceedings relating to your use of my services, or as otherwise allowed by applicable law;

I do not use automated decision-making in the processing of your personal data.

I may collect and process both personal data and special categories of personal data as defined in the GDPR. This includes, or may include:

Client data

- Name;
- Email;
- Phone number;
- Address;
- Payment or bank details;
- Date of birth;
- Location details;
- Device IP address;
- Financial information;
- Medical Records;
- Criminal Records.

I may share your personal data with:

- Instructing solicitors;
- Pupils or mini pupils, under my supervision and training;
- Opposing Counsel, for the purposes of resolving the case;
- My Chambers management and staff who provide administrative services;
- My regulator or legal advisors in the event of a dispute or other legal matter;
- Law enforcement officials, government authorities, or other third parties to meet my legal obligations;
- Any other party where I ask you and you consent to the sharing.

Transfers to third countries and international organisations

I do not transfer any personal data to third countries or international organisations.

I retain your personal data while you remain a client unless you ask me to delete it.

My Retention and Disposal Policy (copy available on request) details how long I hold data for and how I dispose of it when it no longer needs to be held. I will delete or anonymise your personal data at your request unless:

- There is an unresolved issue, such as claim or dispute;
- I am legally required to; or
- There are overriding legitimate business interests, including but not limited to fraud prevention and protecting clients' safety and security.

Your Rights

The General Data Protection Regulation gives you specific rights around your personal data. For example, you have the right to be informed about the information I hold and what I use it for, you can ask for a copy of the personal information I hold about you, you can ask me to correct any inaccuracies with the personal data I hold, you can ask me to stop sending you direct mail, or emails, or in some circumstances ask us to stop processing your details. Finally, if I do something irregular or improper with your personal data you can seek compensation for any distress you are caused or loss you have incurred.
